TRAINING

Windsor-Brunswick Driving Academy will supply a dual controlled (gas & brake) vehicle, a licensed driving instructor, and insurance for the lesson. Windsor-Brunswick Driving Academy will obtain a permit (additional fee \$10) which is to be kept in the instructor's possession during instruction. Should the student have a valid permit or license, he/she must present it to the instructor at time of instruction. The instructor may refuse to allow the student to drive if he/she shows signs of any impairment or actions which could pose a hazard to the student or instructor. Windsor-Brunswick Driving Academy DOES NOT guarantee the issuance of a NJ Drivers License to the student.

The vehicle to be used for instruction has: automatic transmission; _____ standard transmission; and shall be equipped with, at minimum, a brake for both the instructor and the student.

PAYMENT

A \$100 deposit is required upon signing of this contract and will be deducted from the amount owed. 24 hour advance notice is required to reschedule any lesson and must be confirmed with a representative from Windsor-Brunswick Driving Academy or student will be charged for that lesson. Appointments must be mutually agreed upon for date, time, and location. This constitutes the entire agreement between the school and the student and no verbal statements or promises will be recognized. The student may rescind this agreement within 72 hours of the first lesson and upon such rescission shall receive a refund for any lesson or service not conducted or provided.
